


OKDIA Treasurer's Report 2024

OKDIA's operations continue to be managed by the Secretary, Robert Deaves with oversight from the OKDIA Committee. The guiding principle for 2024 was to keep costs in check and maximise income. The result has been neutral with a near break-even profit of GBP137.85.


Some savings were timing related with travel costs reimbursed from the Australian Worlds and fewer editions of the OK magazine resulted in associated cost reduction.

This result was significant in that the operational costs were reduced by 22% compared with the previous period with gross profit increased five percent. Total Capital and Reserves remains at the same level as ended 2023.
